III. Content of quotations

Quotations should be submitted Hard copy in a single envelope and Quotations must contain:

- a) Technical proposal, in response to the requirements outlined in the specifications should comply with:
 - The bidder shall be required to quote for all items.
- b) Price quotation, to be submitted strictly in accordance with Price Quotation Form.

The company's relevant authority must sign both parts of the quotation.

Evaluation Criteria:

Quotations will be evaluated based on the below evaluation criteria and only those companies will be going for the evaluation process who meets the below criteria.

- I. **Company valid registration with the government or AISA**
- II. **Similar Past experience with UN and or other organizations**
- III. **Provide Official bank account details**
- IV. **Warranty of products required (please also clarify the warranty type)**
- V. **Delivery time**
- VI. **United Nations Global Market Place (UNGM) Number is required**

Companies meets the above technical criteria will be further evaluated for the sample checking, sequentially from the first lowest price.

V. Overview of Evaluation Process

Quotations will evaluate based on the compliance with the technical specifications and the total cost of the goods (price quote) and will further evaluate for the sample checking.

VI. Award

UNFPA shall award a Purchase Order to the lowest priced bidder whose bid has been determined to be substantially compliant with the bidding documents.



VII. Right to Vary Requirements at Time of Award

UNFPA reserves the right at the time of award of Contract to increase or decrease by up to 20% the volume of goods specified in this RFQ without any change in unit prices or other terms and conditions.

VIII. Payment Terms

UNFPA payment terms are net 30 days upon receipt of shipping documents, invoice and other documentation required by the contract.
